President Yuhas discussed that Chief Driscoll is in need of assistance and would like to hire a Deputy Chief to assist him. Per President Yuhas, he would like Dave King and Randy Ackley to do a pay study review and we will discuss and vote at the next meeting on hiring a Deputy Chief.
